SEALED BIDS for the furnishing of the necessary materials and construction of the

**Village of Hicksville, Ohio  
250,000 Gallon Elevated Water Storage Tank  
OPWC / ARPA**

will be received by the **Village of Hicksville, 111-113 S. Main Street, Hicksville, OH 43526, until 10:00 a.m., Tuesday, August 2, 2022,** and at that time and place will be publicly opened and read aloud.

**The project consists of construction of a new 250,000 gallon elevated multi-leg water storage tank and necessary appurtenances. The opinion of the probable cost is \$1,600,000.00 .**

The contract documents, including plans and specifications, are on file at the office of the Owner and the Engineer – Poggemeyer Design Group. Documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, [www.pdgplanroom.com](http://www.pdgplanroom.com). “Bid Documents available at the cost of reproduction from “Becker Impressions” and payable directly to Becker Impressions. **Bidders must be on the official bidders list of PDG’s Plan room in order to submit a bid.**

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked - - - **Bid for Village of Hicksville Elevated Water Storage Tank OPWC/ARPA - - - and addressed to the Village of Hicksville, 111-113 S. Main Street, Hicksville, OH 43526.**

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents (The amount of the bid does NOT have to appear on this form).
2. A certified check, cashier's check, or letter of credit in favor of the County in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is 100% payment and performance bond.
3. If you are an out-of-state corporation wishing to submit a bid for this project, you must submit an Ohio Certificate of Good Standing and the name and address of your Ohio Statutory Agent with your bid documents.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of comparable size and complexity, and a complete listing of all subcontractors to be used. The owner intends and requires that this project be completed no later than **December 31, 2023.**

All contractors and subcontractors involved in the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of OAC Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

**DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 CAN BE OBTAINED FROM ANY OF THE OFFICES OF THE DEPARTMENT OF ADMINISTRATIVE SERVICES.**

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations.

The goods and services under this Contract are being funded with monies made available by the **Ohio Publics Work Commission OPWC Small Government and the American Rescue Plan Act (ARPA)** that have statutory requirements commonly known as "American Iron and Steel;" that requires all of the iron and steel products used in the project to be produced in the United States ("American Iron and Steel Requirement") including iron and steel products provided by the Contactor.

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

Bids received after the scheduled bid opening date and time, or not accompanied by a satisfactory bid bond or check, will neither be read nor considered.

The **Village of Hicksville** reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of **60** days after the scheduled closing time for the receipt of bids.
