

## **INVITATION TO BID**

SEALED BIDS for the furnishing of the necessary materials and construction of the

### **BENTON STREET IMPROVEMENTS**

will be received by Village of Sycamore, Ohio at the office of the Mayor, 132 North Sycamore Avenue, Sycamore, Ohio 44882 until

11:00 A.M. (LOCAL TIME)  
THURSDAY, AUGUST 18, 2022

and at that time and place will be publicly opened and read aloud.

The scope of work consists of construction of 1100 feet of waterline, 300 feet of sanitary sewer, and 1600 square yards of pavement resurfacing on Benton Street and Kilborn Street in the Village of Sycamore.

The contract documents, including plans and specifications, are on file at the office of the Village of Sycamore and the Engineer - Poggemeyer Design Group, Inc. (PDG). Documents may be viewed and ordered online or obtained by Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, [www.pdgplanroom.com](http://www.pdgplanroom.com). The cost of printing is to be paid to the printing company at the time the drawings are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **VILLAGE OF SYCAMORE – BENTON STREET IMPROVEMENTS**– and addressed to Village of Sycamore, Attn: Mayor Anthony Flood at 132 North Sycamore Street, Sycamore, Ohio 44882.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check, or letter of credit in favor of the Village of Sycamore, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042

that the bidder was not charged with any delinquent personal property taxes in Wyandot County, Ohio.

The successful bidder will be required to pay not less than the minimum wage rates established by the federal Davis-Bacon Wage Determinations issued by the U.S. Department of Labor.

The Village of Sycamore reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids. This project is being partially funded with Ohio Public Works Commission monies and HB168 funding.

The estimate for the cost of construction is \$425,000.
