SEALED BIDS for the furnishing of the necessary materials and construction of the

**WELLS 4 AND 5 AND RAW WATER IMPROVEMENTS
SPENCERVILLE, OHIO**

will be received by the Village of Spencerville, Ohio at the office of the Village Administrator, 116 South Broadway, Spencerville, Ohio 45887 until

2:00 p.m. (Local Time)
Friday, May 10, 2019

and at that time and place will be publicly opened and read aloud.

The scope of work for this project consists of drilling and installing two (2) new raw water wells and approximately 1,800 lineal feet of new 8" raw water force main to the water treatment plant.

The contract documents, including plans and specifications, are on file at the office of the Village of Spencerville, Ohio and the Architect/Engineer -- Poggemeyer Design Group, Inc. (PDG). The documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, www.pdgplanroom.com for the cost of printing to be paid to the printing company at the time the documents are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **WELLS 4 AND 5 AND RAW WATER IMPROVEMENTS** --- and addressed to the Village of Spencerville, 501 North Broadway, Spencerville, Ohio 45887.

There will be a mandatory **PRE-BID MEETING** held on **THURSDAY MAY 2, 2019 at 10:00 a.m.**, at the proposed well development site which is located at Old Acadia Park, 140 West North Street, Spencerville, Ohio 45887. Any Bidder interested in providing a bid for this project is required to be present for the PRE-BID meeting.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)

2. A certified check, cashier's check or letter of credit in favor of the Village of Spencerville, Ohio in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

This procurement is subject to the EPA policy of encouraging the participation of small businesses in rural areas (SBRAs).

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Allen County, Ohio.

The successful bidder will be required to pay not less than the highest applicable minimum wage rates as established by the federal Davis-Bacon Wage Determinations issued by the U.S. Department of Labor.

The Village of Spencerville, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 90 days after the scheduled closing time for the receipt of bids. This project is being partially funded with Ohio EPA Water Supply Revolving Loan Account (WSRLA) funding with Buy American requirements.

The estimated cost of construction is \$507,000.
