SEALED BIDS for the furnishing of the necessary materials and construction of the

**SOUTH VANCE STREET LIFT STATION IMPROVEMENTS  
CAREY, OHIO**

will be received by the Village of Carey, 127 North Vance Street, Carey, Ohio 43316 until

and at that time and place will be publicly opened and read aloud.

The scope of work for this project consists of the installation of a self-priming suction lift pump station, force main, and demolition of the existing pump station.

The contract documents, including plans and specifications, are on file at the office of the Village of Carey, Ohio and the Architect/Engineer -- Poggemeyer Design Group, Inc. (PDG). The documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, [www.pdgplanroom.com](http://www.pdgplanroom.com) for the cost of printing to be paid to the printing company at the time the documents are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **SOUTH VANCE STREET LIFT STATION IMPROVEMENTS** --- and addressed to the Village of Carey, 127 North Vance Street, Carey, Ohio 43316.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Village of Carey, Ohio in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042

that the bidder was not charged with any delinquent personal property taxes in Wyandot County, Ohio.

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

The Village of Carey, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.
