

**INVITATION TO BID**

SEALED BIDS for the furnishing of the necessary materials and construction of the

**WOO - N. BALTIMORE CBD ENH  
VILLAGE OF NORTH BALTIMORE, OHIO**

will be received by the Village of North Baltimore at 205 North Main Street, North Baltimore, Ohio 45872 until

12:00 NOON (Local Time)  
FRIDAY, APRIL 26, 2019

and at that time and place will be publicly opened and read aloud.

The scope of work consists of the reconstruction of 500 feet of North Main Street including new pavement, curb and gutter, decorative sidewalk, street lighting and traffic signal replacement. Associated work includes new signage, pavement markings, storm sewer installation and restoration.

**Only ODOT pre-qualified contractors are eligible to submit bids for this project. Pre-Qualification status must be in force at the time of the bid, at the time of award, and through the life of the construction contract. Subcontractors are not subject to the pre-qualification requirement. Bidders are also expected to provide an experience statement indicating their ability to perform the work as required in the contract documents. Bidders must be on the official bidders list of PDG's Planroom in order to submit a bid.**

**The DBE goal for this project is 7%.**

The contract documents, including plans and specifications, are on file at the office of the Village of North Baltimore and the Engineer - Poggemeyer Design Group, Inc. (PDG). Documents may be viewed and ordered online or obtained by Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, [www.pdgplanroom.com](http://www.pdgplanroom.com). The cost of printing is to be paid to the printing company at the time the drawings are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **WOO - N. BALTIMORE CDB ENH**--- and addressed to Mr. Michael Brillhart, Village Administrator at the Village of North Baltimore, 205 N. Main Street, North Baltimore, Ohio 45872.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Village of North Baltimore, Ohio in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Wood County, Ohio.

The successful bidder will be required to pay DAVIS-BACON WAGE RATES.

The Village of North Baltimore, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.

The estimate for the cost of construction is \$863,000.
