

## ADVERTISEMENT FOR BIDS

SEALED BIDS for the furnishing of the necessary materials and construction of the

### **CHICAGO AVENUE WATERLINE REPLACEMENT - OPWC FOR THE VILLAGE OF HICKSVILLE, OHIO**

will be received by the **VILLAGE OF HICKSVILLE, 111-113 S. Main Street, Hicksville, Ohio 43526** at the Village Office until 2:00 p.m., local time on Tuesday, August 7, 2018, and at that time and place will be publicly opened and read aloud.

The work will consist of installing approximately 850 lineal feet of 6" waterline under pavement, along with hydrants, 6" valves with boxes, fittings, 13 residential services, pavement repair, and necessary appurtenances on Chicago Avenue from Westwood Place northerly approximately to Meadow Lane. The estimate for the cost of construction is \$125,290.00.

The contract documents, including plans and specifications, are on file at the office of the Village of Hicksville, Ohio and the Engineer for the project - - Poggemeyer Design Group, Inc., 101 Clinton Street, Ste. 1300, Defiance, Ohio 43512. The documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone (419) 385-5303, [www.pdgplanroom.com](http://www.pdgplanroom.com) for the cost of printing to be paid to the printing company at the time the documents are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked - - **BID FOR – CHICAGO AVENUE WATERLINE REPLACEMENT – OPWC – FOR THE VILLAGE OF HICKSVILLE, OHIO** - and addressed to the **Village of Hicksville, 111-113 South Main Street, Hicksville, OH 43526**.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents (The amount of the bid does NOT have to appear on this form).
2. A certified check, cashier's check or letter of credit in favor of the **Village** in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is 100% payment and performance bond.
3. If you are an out-of-state corporation wishing to submit a bid for this project, you must submit an Ohio Certificate of Good Standing and the name and address of your Ohio Statutory Agent with your bid documents.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. **The owner intends and requires that this project be fully completed by December 31, 2018.**

All contractors and subcontractors involved in the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

**DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 OF THE REVISED CODE CAN BE OBTAINED FROM ANY OF THE OFFICES OF THE DEPARTMENT OF ADMINISTRATIVE SERVICES.**

Bidders must comply with the prevailing wage rates on Public Improvements in **Defiance County and the Village of Hicksville, Ohio** as determined by the Ohio Department of Industrial Relations.

Bids received after the scheduled bid opening date and time, or not accompanied by a satisfactory bid bond or check, will neither be read nor considered.

The **Village of Hicksville** reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.
