

INVITATION TO BID

SEALED BIDS for the furnishing of the necessary materials and construction of the

EUCLID ROAD, MINER STREET, AND PROSPECT STREET RESURFACING VILLAGE OF NEW LONDON, OHIO

will be received by Village of New London, Ohio at the office of the Village Administrator, Village of New London, 115 East Main Street, New London, Ohio 44851 until

10:00 A.M. (LOCAL TIME)
FRIDAY, SEPTEMBER 20, 2019

and at that time and place will be publicly opened and read aloud.

The scope of work consists of milling and resurfacing approximately 2,300 feet of Euclid Road, Miner Street, and Prospect Street within the Village of New London.

The contract documents, including plans and specifications, are on file at the office of the Village of New London and the Engineer - Poggemeyer Design Group, Inc. (PDG). Documents may be viewed and ordered online or obtained by Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, www.pdgplanroom.com. The cost of printing is to be paid to the printing company at the time the drawings are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions. **Bidders must be on the official bidders list of PDG's Planroom in order to submit a bid.**

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **VILLAGE OF NEW LONDON – EUCLID ROAD, MINER STREET, AND PROSPECT STREET RESURFACING** --- and addressed to Village of New London, Attn: Shawn Pickworth, Village Administrator at 115 East Main Street, New London, Ohio 44851.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Village of New London, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Huron County, Ohio.

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

The Village of New London reserves the right pursuant to ORC.9.312 and the Village of New London Code of Ordinances Section 103.01 to reject and any and all bids and to waive any non-material irregularity in determining the lowest responsive and responsible bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.

The estimate for the cost of construction is \$67,200.00.
