SEALED BIDS for the furnishing of the necessary materials and construction of the

**WATER TREATMENT PLANT HAB (OZONE) TREATMENT SYSTEM
PUT-IN-BAY, OHIO**

will be received by the Village of Put-in-Bay, Ohio at the offices of Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402 until

10:00 a.m. (Local Time)

and at that time and place will be publicly opened and read aloud.

The scope of work for this project consists of the installation of one ozone treatment system and associated piping and equipment. Modification to current water treatment plant to accommodate ozone improvements.

The contract documents, including plans and specifications, are on file at the office of the Village of Put-in-Bay, Ohio and the Architect/Engineer -- Poggemeyer Design Group, Inc. (PDG). Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **WATER TREATMENT PLANT HAB (OZONE) TREATMENT SYSTEM** --- and addressed to the Village of Put-in-Bay, Ohio c/o Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Village of Put-in-Bay, Ohio in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

This procurement is subject to the EPA policy of encouraging the participation of small businesses in rural areas (SBRAs).

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Ottawa County, Ohio.

The successful bidder will be required to pay not less than the highest applicable minimum wage rates as established by the federal Davis-Bacon Wage Determinations issued by the U.S. Department of Labor.

The Village of Put-in-Bay, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 OF THE REVISED CODE CAN BE OBTAINED FROM THE OFFICE OF THE OHIO FACILITIES CONSTRUCTION COMMISSION.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids. This project is being partially funded with Ohio EPA Water Supply Revolving Loan Account (WSRLA) with Buy American requirements and Ohio Public Works Commission funds.
