

INVITATION FOR BIDS

SEALED BIDS for the furnishing of the necessary materials and construction of the

PAYNE COMMUNITY PARK RESTROOM (NATURE WORKS PROJECT) FOR THE VILLAGE OF PAYNE, OHIO

will be received by the **Village of Payne, 119 N. Main St., P.O. Box 58, Payne, Ohio 45880, until 7:00 p.m., Monday, August 26, 2019**, and at that time and place will be publicly opened and read aloud.

The project consists of providing all materials and labor to construct a 20' x 10', restroom facility in the Village of Payne. Also included is concrete pavement and sidewalks. Engineer's Estimate \$66,000.00. The Owner requires this project to be substantially completed by September 1, 2020, and Final Completion no later than September 30th, 2020.

The contract documents, including plans and specifications, are on file at the office of the Village of Payne and the Engineer -- Poggemeyer Design Group, Inc. (PDG). A set may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, www.pdgplanroom.com for the cost of printing to be paid to the printing company at the time the drawings are picked up. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked - - - **BID FOR PAYNE COMMUNITY PARK RESTROOM (NATUREWORKS PROJECT)** - - - and addressed to the **Village of Payne, 119 N. Main St., P.O. Box 58, Payne, Ohio 45880**.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the **Village**, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is 100% payment and performance bond.

The successful bidder will not be required to pay the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

Bids received after the scheduled bid opening date and time, or not accompanied by a satisfactory bid bond or check, will neither be read nor considered.

The **Village of Payne** reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of **60 days** after the scheduled closing time for the receipt of bids.
