

INVITATION TO BID

SEALED BIDS for the furnishing of the necessary materials and construction of the

**OAK STREET IMPROVEMENTS
VILLAGE OF GRAFTON, OHIO**

will be received by the Village of Grafton at the office of the Clerk/Treasurer, 960 Main Street, Grafton, Ohio 44044 until

12:00 Noon (Local Time)
Wednesday, August 29, 2018

and at that time and place will be publicly opened and read aloud.

The scope of work consists of completing reconstruction of approximately 850 feet of Oak Street, widening the pavement to 25 feet with new concrete curb/gutter and bituminous asphalt concrete pavement; 1,227' of new 8" diameter waterline (78' horizontal cased bore crossing railroad), 694' of new 8" sanitary sewer (57' horizontal cased bore crossing railroad); 1,508' of new 12", 15", 18", and 24" storm sewer (84' horizontal cased bore crossing railroad); new service laterals, precast concrete manhole and catch basin structures, and other necessary appurtenances.

The contract documents, including plans and specifications, are on file at the office of the Village of Grafton, Ohio and the Architect/Engineer -- Poggemeyer Design Group, Inc. (PDG). The documents may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, Telephone 419-385-5303, www.pdgplanroom.com for the cost of printing to be paid to the printing company at the time the documents are picked up. Shipping and tax charges are the bidder's responsibility and are payable directly to Becker Impressions.

The Engineer for the Project is Poggemeyer Design Group, Inc., 1168 North Main Street, Bowling Green, Ohio 43402.

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked --- **OAK STREET IMPROVEMENTS** --- and be addressed to the Village of Grafton, 960 Main Street, Grafton, Ohio 44044.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Village of Grafton, Ohio, in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid and prior to the time the contract is entered into, bidders shall submit the affidavit required under the Ohio Revised Code, Section 5719.042 that the bidder was not charged with any delinquent personal property taxes in Lorain County, Ohio.

The successful bidder will be required to pay not less than the minimum wage rates established by the Department of Industrial Relations of the State of Ohio.

The Village of Grafton, Ohio reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 OF THE REVISED CODE CAN BE OBTAINED FROM ANY OF THE OFFICES OF THE DEPARTMENT OF ADMINISTRATIVE SERVICES.

No bidder may withdraw his bid for a period of 90 days after the scheduled closing time for the receipt of bids. This project is being partially funded with Ohio Public Works Commission (OPWC) funds and Ohio Water Development Authority funds.

The opinion of the probable cost of construction is \$993,990.
