

INVITATION TO BID

SEALED BIDS for the furnishing of the necessary materials and construction of the

WATER METER REPLACEMENT - OPWC FOR THE VILLAGE OF CONTINENTAL, OHIO

will be received by the Village of Continental, P.O. Box 447, 110 N. Main Street, Continental, OH 45831 until 12:00 Noon, local time Thursday, November 1, 2018, and at that time and place will be publicly opened and read aloud.

The scope of work consists of installation of a complete meter and meter reading system per specifications.

The contract documents, including specifications, are on file at the Village and the Engineer - Poggemeyer Design Group, Inc. (PDG), 101 Clinton Street, Suite 1300, Defiance, OH 43512. A set may be viewed and ordered online or obtained from Becker Impressions, 4646 Angola Road, Toledo, Ohio 43615, www.pdgplanroom.com for the cost of printing to be paid to the printing company. Shipping and tax charges are the bidder's responsibility and payable directly to Becker Impressions. **Bidders must be on PDG's Planroom Official Bidder's list in order to place a bid.**

All bids must be signed and submitted on the blanks which are bound in this booklet. Bids must state the unit prices in the blanks provided and be enclosed in a sealed envelope marked -- **WATER METER REPLACEMENT (OPWC)** -- and addressed to the Village of Continental.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents (The amount of the bid does NOT have to appear on this form).
2. A certified check, cashier's check or letter of credit in favor of the Village in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is 100% payment and performance bond.
3. If you are an out-of-state corporation wishing to submit a bid for this project, you must submit an Ohio Certificate of Good Standing and the name and address of your Ohio Statutory Agent with your bid documents.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experience on projects of similar size and complexity, and a complete listing of all subcontractors to be used. The owner intends and requires that this project be completed no later than January 30, 2019.

Bids received after the scheduled bid opening date and time, or not accompanied by a satisfactory bid bond or check, will neither be read nor considered.

Bidders must comply with the prevailing wage rates on Public Improvements, as determined by the Ohio Department of Commerce, Bureau of Wage and Hour Administration, 614.644.2239. All contractors and subcontractors involved in the project will, to the extent practicable use Ohio products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

DOMESTIC STEEL USE REQUIREMENTS AS SPECIFIED IN SECTION 153.011 OF THE REVISED CODE APPLY TO THIS PROJECT. COPIES OF SECTION 153.011 CAN BE OBTAINED FROM ANY OF THE OFFICES OF THE DEPARTMENT OF ADMINISTRATIVE SERVICES.

The Village of Continental reserves the right to reject any and all bids and to waive any irregularity in any bid and to determine the lowest and best bidder.

No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids. This project is being partially funded by OPWC funds.

The opinion of the probable cost is \$121,000.00.
