

Notice to Contractors

Sealed proposals will be received by the Board of County Commissioners, **Putnam County**, Ohio, for the **Village of Continental, Parks, Sidewalk and Street Improvements (CDBG)** until 9:30 a.m., local time, on Tuesday, May 29th, 2018, at which time the bids will be publicly opened and read aloud.

The work will consist of the following projects.

- Contract A – Sparling Park Improvements including removal of existing playground equipment and gazebo and construction of a 200 SF restroom facility. The Engineer’s estimate for this project is \$71,500.
- Contract A1 – Sparling Park Improvements also consisting of surfacing a 2,350 SF parking lot estimated at \$4,400.
- Contract B – In addition Sparling Park construction includes ADA Parking Spaces, two (2) total, estimated at \$9,900.
- Contract C – Various Street Improvements throughout the Village consisting of approximately 8,566 SY of milling and resurfacing with full depth pavement repairs estimated at \$202,500.
- Contract D – Sidewalk removal and replacement along Main Street, 5,672 SF, and new sidewalks near the Library, 2,164 SF, estimated at \$77,500.

The contract documents, including plans and specifications, are on file at the office of the Engineer for the Project - Poggemeyer Design Group, Inc., (PDG) 101 Clinton Street, Suite 1300, Defiance, OH 43512. Shipping and tax charges are the bidder’s responsibility and payable directly to Becker Impressions. **Bidders must be on the official bidders list of PDG’s Planroom in order to submit a bid.**

Bids must be submitted on the forms bound in the Bidding Document; must contain the names of every person or company interested therein; and shall be accompanied by either a Bid Guaranty and Contract Bond with satisfactory corporate surety in the amount of 100% of the bid amount, or by a certified check or bank check on a solvent bank in the amount of not less than 10% of the maximum bid amount, subject to the conditions provided in the Instructions to Bidders. The successful Bidders will be required to furnish satisfactory Performance and Maintenance and Guarantee bonds in the amount of 100% of the respective bid. The Owner may waive the requirement that the Payment and Performance Bonds be underwritten by a surety company and may authorize in lieu thereof, a personal bond backed by an irrevocable letter of credit from a local lending institution, utilizing the form provided, for the full value of the Contract.

SPECIAL ATTENTION MUST BE GIVEN to all of the requirements contained in this bid packet, particularly to the Federal Labor Standards Provisions and Davis Bacon Wages, various insurance requirements, various equal opportunity provisions, and the requirement for a payment and performance bond for 100% of the contract price.

Any bid may be withdrawn prior to the scheduled closing time for the receipt of bids, but no bidder shall withdraw his bid within 60 days after the actual opening thereof. The County reserves the right to reject any or all bids, waive irregularities in any bid, and to accept any bid which is deemed most favorable to the County.
