The scope of work consists of furnishing and delivering a sludge dewatering centrifuge, controls, and necessary accessories for installation as part of a future project.

The bid guaranty may be of two forms:

1. A Bid Guaranty and Contract Bond using the form in the Contract Documents. (The amount of the bid does NOT have to appear on this form.)
2. A certified check, cashier's check or letter of credit in favor of the Erie County Board of Commissioners in the amount of 10% of the bid. If the contract is awarded, a Contract Bond will be required, which is a 100% payment and performance bond.

After the award of the contract let by competitive bid, and prior to the time the contract is entered into, bidders shall submit the affidavit required under Section 5719.042 of the Ohio Revised Code, stating that the bidder was not charged with any delinquent personal property taxes in Erie County, Ohio.


No bidder may withdraw his bid for a period of 60 days after the scheduled closing time for the receipt of bids.

The estimated cost of construction is \$356,200.
